TRAVEL & PARTICIPATION AGREEMENT

This Agreement outlines the commercial and participation terms for the Vante Collective China Curated Sourcing Experience (“the Experience”).

By confirming a booking, the Participant agrees to the terms below.

1. Parties

Organiser:

Vante Collective (“the Organiser”)

Participant:

The individual completing the booking (“the Participant”)

2. Purpose of the Experience

The Experience is designed to provide curated access to:

- Pre-vetted manufacturers
- Building materials and interior finishes
- Furniture and home furnishings
- Lighting and smart home solutions
- Selected trade exhibitions, including the Canton Fair

Vante Collective acts as a facilitator only and does not provide construction, installation, or interior design services unless separately contracted.

3. Booking & Participation

- Participation is voluntary.
 - Bookings are confirmed only upon receipt of the required deposit.
 - Places are limited and allocated on a first-come basis.

4. Package Inclusions

Depending on the selected package, inclusions may consist of:

- Economy return flights (upgradeable)
- Hotel accommodation as specified
- Group transfers for scheduled activities

- Selected meals outlined in the itinerary
- Factory, showroom, and trade visits
- Design or sourcing consultations
- China SIM card with data and VPN
- Visa support letter
- Welcome pack

Final inclusions are confirmed in writing at booking.

5. Items Not Included

Unless expressly stated, the following are excluded:

- Travel insurance (mandatory)
 - Visa application fees
 - Personal expenses
 - Optional dining or spa services
 - Flight or accommodation upgrades
 - Interior design services
 - Procurement, shipping, customs, or logistics

6. Travel Arrangements

- Group travel responsibility begins at official group check-in.
 - Participants travelling from outside the departure city are responsible for their own arrangements.
 - The Organiser is not liable for missed connections or delays outside the group itinerary.

7. Payments

- All payments must be made by the stated deadlines.
 - Payments are non-refundable except where required by law.
 - Prices may be quoted in USD, GBP, or ZAR, as confirmed at booking.
 - Late payment may result in cancellation of the booking without refund.

8. Cancellation by Participant

Cancellations must be submitted in writing.

- **121+ days:** deposit forfeited
- **61–121 days:** deposit + interim payment forfeited
- **31–60 days:** all payments forfeited
- **0–30 days:** 100% of tour cost forfeited

These reflect non-recoverable supplier commitments.

9. Cancellation by Organiser

Vante Collective reserves the right to cancel the Experience due to unforeseen circumstances or insufficient participation.

In such cases, payments will be refunded minus unrecoverable third-party costs.

10. Code of Conduct

Participants agree to:

- Act respectfully and professionally
- Follow group schedules and instructions
- Respect suppliers, partners, and fellow participants
- Comply with local customs and regulations

Failure to comply may result in removal from activities without refund.

11. Governing Law

This Agreement shall be governed by the laws of the United Kingdom unless otherwise stated.
